## Addressing family and domestic violence in the Social Security Guide | Department of Social Services Ministers

"Victims of family, domestic, and sexual violence should not be unfairly punished as a result of how their relationship is recognised under social security law.

"Violence against women and children is a problem of epidemic proportions in Australia. The impact of this ripples out across families in Australia, communities and society.

"If we are to end violence in one generation, we must ensure our social security safety net recognises the circumstances of people who are experiencing violence."

A person is a member of a couple under the Social Security Act 1991 if they have a relationship with another person, where both people are over the age of consent, are committed to each other on a permanent or indefinite basis, are not in a prohibited relationship and are either legally married, or in a registered relationship, or in a de facto relationship.

The amendments clarify how the circumstances of victims of family, domestic and sexual violence should be considered in the administration of member of a couple considerations.

This aligns with the vision of the *National Plan to End Violence against Women and Children 2022–2032*, which describes how all areas of society need to work together over the next 10 years to end violence against women and children.
